Enjoy pre-tax savings on qualified dental, vision and preventive care expenses with a Limited Purpose Flexible Spending Account.



Use your tax-advantaged Limited Purpose Flexible Spending Account (LP-FSA) to pay for qualified dental, vision and preventive care for you, your family and any dependents. The IRS determines which expenses<sup>1</sup> are qualified for reimbursement. Examples of qualified expenses include the following:

## Dental

- Co-insurance
- Deductibles for plans
- Dental care (non-cosmetic)
- Dental reconstruction (implants)
- Dentures and bridges
- Diagnostic services
- Occlusal guards to prevent teeth grinding
- Office visits
- Operations
- Oral and teeth pain products
- Orthodontia (not for cosmetic reasons)
- Transportation and travel expenses (essential to receive medical care)
- X-ray fees

While this list identifies the eligibility of some of the most common LP-FSA expenses, this list is not meant to be all-inclusive.

## Eligible Expense Scanner

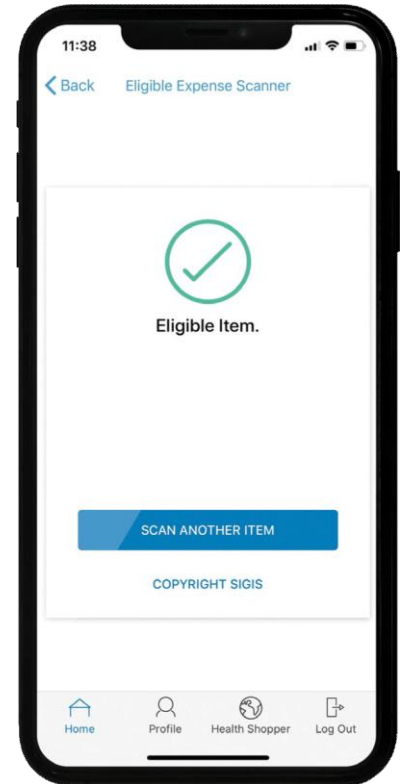
